HRI has a dedicated secure online Racing Administration System (RÁS), where you can carry out all your day-to-day racing administration including managing your HRI owner account, make payments to your account, view your balance, make requests, register or cancel authority to acts (nomination of trainers) or racing colours.

When you register as an owner with HRI, you will be issued with a 10 digit pin code to facilitate your access to RÁS online. Once registered to use RÁS you may then delegate persons on your account to carry out various tasks on your behalf.
