

SECTION 8 : BANK DETAILS

To access any prize-money won, the owner must submit bank details to allow HRI to transfer this prize-money to their nominated account.

SECTION 9 : HORSE RACING IRELAND ACCOUNT HOLDER

HRI has a dedicated secure online Racing Administration System (RÁS) where you can carry out all your day-to-day racing administration including managing your HRI owner account, making requests, registering or cancelling your authorities to act (nomination of trainers) and registering or cancelling your colours.

When you register as an owner with HRI, you will be issued with a 10 digit pin code to facilitate your access to RÁS online. Once registered to use RÁS, you may then delegate persons on your account to carry out various tasks on your behalf.
