### **TYPES OF OWNERSHIP**



**SOLE OWNER** Run a horse(s) in your own name and colours



PARTNERSHIP 2-4 sole owners join together to race a horse(s)



**CLUB** Unlimited number of people race a horse(s) collectively under one name



SYNDICATE 3 - 100 people race a horse(s) collectively under one name



COMPANY Run a horse(s) under a company name

### SOURCE YOUR HORSE

#### TRAINER

Very often trainers have horses in their yard available for sale; this may be a young horse they have purchased or bred themselves, a share in a current horse, or a horse they wish to lease.

#### AUCTION

Seeking advice from your trainer or bloodstock agent will help you when purchasing your horse at auction.

#### **CLAIMING RACES**

These types of races offer owners an opportunity to purchase horses directly out of a race, at an advertised racecard fee.

#### LEASING

Leasing allows an owner to enjoy the thrill of ownership without the initial expense of buying a horse. Leases are usually under a fixed term agreement. We recommend all lease agreements are in writing.

#### SELECT YOUR TRAINER

Selecting your trainer is one of the most important decisions you as a racehorse owner will have to make. Your trainer can assist and advise you with the purchasing of a horse and will manage the day to day training of your horse.

#### JOIN A CLUB OR SYNDICATE

Joining an existing syndicate or club can be a fun and affordable introduction to racehorse ownership. Many trainers have syndicate shares available. Alternatively, you may wish to set up your own syndicate or club.
