Syndicate Registration Form

Introduction

This form is necessary to register a syndicate in a horse to be raced on the track in Ireland.

The syndicate name or the agent name may appear on the racecard. The “Registered Agent” is defined as the individual that has been nominated by the members to be solely responsible for the management of the syndicate with Horse Racing Ireland.

Prior to completing this form we recommend that you read the accompanying Guide to Ownership and familiarise yourself with the various aspects of syndicate registrations. Although not compulsory, it is strongly recommended that a separate written agreement is drawn up and signed by all syndicate members. Further information on syndicate agreements can be found in the aforementioned guide.

If you are registering your syndicate for the first time the agent should have completed the Owner Registration Form at this stage. Current syndicates that are adding or replacing horses need to complete this form only. At this point may we remind you that the list of syndicate members must be identical in all horses owned by that syndicate. A limited number of member changes are permitted at the discretion of Horse Racing Ireland. All such changes must be lodged, in writing on the official form.

Please note that on Syndicate Registration Form must be completed for each horse owned by the syndicate and a syndicate must have a minimum of 5 members. Minimum share per member is 1%.

Incomplete forms and/or insufficient funds will result in your application being returned unregistered. Syndicates are subject to registration and annual renewal fees.

Section 3: Conditions of Syndicate Registration - All members must read this section

- We the undersigned agree to register the Syndicate in accordance with the Horse Racing Ireland Orders, Rule 122 of the Rules of Racing and I.N.H.S. Rules and agree to appoint the above named Registered Agent who shall be solely responsible for management of the syndicate with Horse Racing Ireland.
- The Syndicate Registration shall terminate once Horse Racing Ireland is notified in writing by the Registered Agent. The Syndicate Registration will incur an annual renewal charge on 1st January of every year it is registered.
- Horse Racing Ireland shall not be under any liability whatsoever in respect of any payments by syndicate members to the Registered Agent.
- This form is prepared to meet the requirements of the Horse Racing Ireland Orders, Rules of Racing and I.N.H.S. Rules. It is not specially intended as a legal document and the interest of the parties concerned will therefore be best protected by a separate written agreement.
- The following information is strictly confidential and may be used by Horse Racing Ireland and its subsidiaries for racing related marketing purposes.
- Horse Racing Ireland may release details of names and addresses to racecourses where you may intend to, or have had runners, for ownership related customer services. *Please advise if you do not wish these details to be released.*
